#### **INTEREST FREE DEPOSITS:**

- 1. An amount calculated @ 36/- per sqft. On Built up Area of the flat shall be deposited by the purchaser with the developer as interest free security deposit, on account of maintenance of Urban Vista Project (to be paid on possession).
- 2. Security deposit for individual mater in respect of apartment shall be payable by the allotee directly to the WBSEDCL Ltd as and whenever demanded.

3. Security deposit towards Panchayat Tax may be reasonably required from the allotee by the promoter on or before taking possession of the apartment.
